EasyCore, EasyDB, EasyCopy, EasyGraphiX, EasyCGM, EasyVect, EasyView and EasyPlot are products fully owned by agitec ApS and produced by The EasyCopy Company.

### Copyright

The downloaded/enclosed software ("the Software") is owned by The EasyCopy Company and is protected by copyright laws and international treaty provisions. You will not remove any copyright notice from the materials. You agree to prevent any unauthorized copying of the materials. Except as expressly provided herein, The EasyCopy Company does not grant any express or implied right to you under The EasyCopy Company patents, copyrights, trademarks, or trade secret information. EasyCopy products work with open source software under various Open Source License Agreements. Information about these Open Source License Agreements is found in [www.myeasycopy.com](http://www.myeasycopy.com) under Documentation, including information about where to retrieve source code for software under Open Source License Agreements.

### License

The EasyCopy Company hereby grants you, the original licensee, a non-exclusive, non-assignable license of the type you have chosen for software licensed by The EasyCopy Company. This will be specified in your invoice, in your License Document and/or our contract.

You are allowed to install and use the software as specified for the License Type for which you are licensed on computers owned, leased, or otherwise controlled by you.

The Software can be installed anywhere on your file system.

You agree to use your best efforts to protect the Software from any use, reproduction, or other distribution except as specifically allowed under this License Agreement.

### Evaluation

When the Software is installed without a password/or with a temporary license, it is installed for Evaluation. Any limitations, which apply to the functionality of the Software, when installed for evaluation, are described in the manual.

All terms and conditions specified for a Software License apply equally for Evaluation, subject only to the exceptions expressly provided herein.

Evaluation is royalty-free (a fee for media and handling may apply).

You may install the Software for evaluation on any number of computers for a period of time not exceeding 30 days or the time you have agreed with The EasyCopy Company to evaluate the Software. When you have completed your evaluation, you must either license one or more copies or completely remove the Software from all computers where it has been installed.

### License Types

*Single Node License (Not available for EasyPlot)*

A Single Node License is permanently locked to a specific computer; this is the computer for which the Software is licensed. Locking to a specific computer implies that the Software can only be executed on that computer.

A Single Node License foreordains that the Software can only use the local display(s) of the computer to which the license is locked. This implies that the Software cannot be used through remote login, remote shell, or similar.

### *Fixed License for Multiple Nodes:*

A Fixed License is locked for a period of at least 60 days to a single computer and user. When the minimum period of 60 days has expired you may at any time unlock the license and reuse it on another computer; the license is then no longer available on the first computer, and on the computer where it is reused it is again locked for a period of at least 60 days.

As long as the Software is locked to a specific computer it can only be executed on that computer by the licensed user.

### *Floating Site License: (Not available for EasyView)*

A Floating Site License can be used only at one physical address, or as stated in the license document. A license can be checked out by an employee working only at that physical address.

### *Floating Worldwide License: (Not available for EasyView)*

A Floating Worldwide License can be used by all employees in the Licensee's organization and entities fully owned and operated by the Licensee. It can be checked out only by employees working for the Licensee or an entity fully owned and operated by the Licensee.

### *License Types (EasyPlot)*

*Licenses require a License Dispatcher provided by The EasyCopy Company. The License Dispatcher must be installed on a server that can be accessed from any computer on which you want to use the Software.*

*EasyPlot is licensed for one site only if not specified differently (and for a minimum of 10 individual users) – the details of the site are described on the License to Use Document that will accompany the invoice.*

### *General Conditions for Floating Licenses:*

Whether the license is Site or Worldwide, the license becomes locked to a single computer as soon as the Software is activated (starting to execute) on that computer.

It remains locked to that computer for a period that depends on how the Software was started:

\* If the Software was started through its graphical user interface it is locked for a period of minimum 1 minute.

\* If the Software was started through its command line interface it is locked for a period of minimum 30 minutes, unless it was started solely for the purpose of displaying version or help information.

\* If the software is used as a Command Line Server Solution it is locked for a period of minimum 30 minutes.

After the minimum period has expired the Software remains locked as long as any of its parts are still executing or waiting.

Fixed and Floating licenses require a License Dispatcher provided by The EasyCopy Company. The License Dispatcher ecd daemon must be installed on a server with a static IP address. To get access to a license from any computer on which you want to use the Software you need to allow ecd daemon to communicate through the firewall.

### *Common for All License Types*

The Password you get for your license must be installed to enable those capacities of the Software, which are covered by the license you have chosen. After you have installed the Password, other capacities may still be available with the limitations provided for, when the Software is installed for Evaluation, and you are allowed to continue Evaluation of these capacities. However, the Password only assists you in using the Software correctly according to the terms valid for your license. Your rights and obligations are the ones set forth in this Agreement.

You are allowed to copy the Software for normal backup purposes. You may only restore the materials from a backup on the computer or server for which the Software is licensed.

## Updates

If the Software contained within this package is acquired through The EasyCopy Company update program, Software Subscription Service, Lease or Annual Subscription, this updated version of the Software is the only version supported.

You may only install this updated version on the computer for which the Software is licensed. Unless otherwise agreed by submitting a Statement to Change Password form.

## Termination

The license to use the Software is either effective within the contractual Subscription period and will terminate automatically at the end of this period if not prolonged or for purchased licenses the license to use the Software is effective until terminated. You may terminate it at any time by deleting the software or destroying or returning the media on which the programs reside.
